

GENERAL TERMS AND CONDITIONS TUTU POINTS

1. Participation in the TuTu Points Program constitutes each participant's full and unconditional agreement to these general terms and conditions as set forth herein.
2. The TuTu Points is a loyalty card reward-program sponsored by Goisco B.V.. Therefore to participate in the TuTu Points Program all participants must have a valid Goisco membership card. Only the valid registered member will be deemed to be the participant.
3. In the event the membership card expires, accumulated TuTu Points will stay valid for **1 YEAR** after the expiration date. If the participant does not redeem his/her membership by such time all accumulated TuTu Points will be forfeited in their entirety without any compensation.
4. Expired TuTu Points will then be deleted/removed from the participant's membership card and will not be carried over to future membership card.
5. The following are **NOT** eligible to participate in TuTu Points: employees of Goisco B.V., corporations, associations, including school organizations and other business or group entities of collaborations.
6. The TuTu Points can only be collected by purchasing participating products, available while supplies last.
7. TuTu Points have absolutely **NO CASH** value and are only redeemable for offered participating products.
8. Only participating products with the TuTu Points-sign will be awarded with TuTu Points.
9. TuTu Points will automatically be credited to your valid membership card. If a participant does not have his/her valid membership card at the time of purchase the TuTu Points will not be credited.
10. The participant's personal receipt will show his/her TuTu Points balance.
11. Participating products are subject to change at the sole discretion of Goisco B.V..
12. To redeem the TuTu Points the participant needs to show his/her valid membership card as this will show his/her total balance of TuTu Points saved.
13. Goisco B.V. reserves the right to shorten, extend, modify or cancel the TuTu Points Program, including these general terms and

conditions, at any time in its sole discretion, even though such changes may affect a participant's ability to accumulate or redeem TuTu Points. A participant's continued participation in the TuTu Points Program constitutes his/her acceptance of any changes or modifications to these general terms and conditions.

14. Goisco B.V. reserves the right to change or modify the methods by which participants may collect TuTu Points, as well as amend the Points calculation formula at any time with or without prior notice, in its sole discretion.
15. Goisco B.V. reserves the right to take any action it deems appropriate and/or necessary, in its sole discretion, in the event that Goisco B.V. believes that a participant has violated any of these general terms and conditions.
16. Participating products to be redeemed will be communicated on display and/or through other methods at the store, and are available while supplies last.
17. As a condition of participating in the TuTu Points Program the participant agrees that, except where prohibited, any and all disputes, claims and causes of action arising out of or connected with the TuTu Points Program shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate Court of First Instance of the Netherlands Antilles.
18. All issues and questions concerning the construction, validity, interpretation and enforceability of these general terms and conditions, participant's rights and obligations, or the rights and obligations of Goisco B.V. in connection with the TuTu Points Program shall be exclusively governed by and construed in accordance with the laws of the Netherlands Antilles.
19. The TuTu Points Program is subject to all applicable laws and regulations. If any provision of these general terms and conditions is found to be invalid or unenforceable by the court of competent jurisdiction, such provision shall be severed from the remainder of these general terms and conditions, which will otherwise remain in full force and effect.
